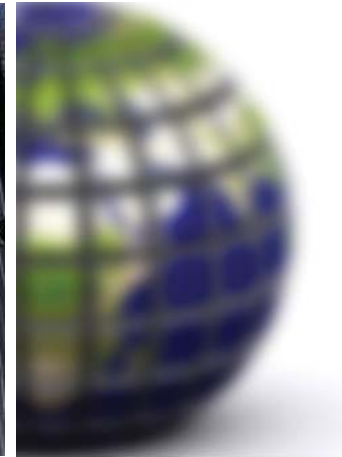

### Route 2

Educational program consists of submitting a minimum 15,000 words financial consultancy report based on an approved topic. Members who complete the education component, and complete three years of financial management experience are eligible to receive and use the Institute's internationally respected designation. The Institute issues this designation by means of the Certificate of Certified Financial Consultant ®.
